



We are excited to be offering in person visitations at Village Health Care. The purpose of this document is to provide guidelines for safe and supervised visitation while Village Health Care remains closed to visitors due to the Governor's guidelines for LTC/SNF buildings during the COVID-19 pandemic.

General Guidelines

- The patient and visitor(s) will be required to wear proper masks and the patient will be provided a face shield for additional protection.
- All visitors will be required to sign into the visitor log and will be required to answer the appropriate screening questions and have their temperature taken before they will be allowed to the visitation area.
- The visit will be monitored from a distance to provide privacy while also ensuring there is no contact that would break social distancing, food/beverages are not shared, and masks/face shields are not removed.
- You must pre -schedule your visits with our Health Services Liaison. You can do that by calling 503-312-5689 or emailing at hsl@villagehc.com
- Patient must agree to visit and be free of signs or symptoms (including fever) of COVID-19. Patient will also agree to the conditions of visitation.
- Visitor(s) must agree to visit and be free of signs or symptoms (including fever) of COVID-19. Visitor(s) will also agree to the conditions of visitation
- If the visitor has had lab confirmed or suspected COVID-19 the visit must be approved by the Director of Nursing to ensure proper timelines have lapsed to avoid potential exposure to the patient and staff.

Rules to Follow During Your Visitation

- Visits are 30 minutes in duration. All visitors will be required to sign into the visitor log and will be required to answer the appropriate screening questions and have their temperature taken before they will be allowed to the visitation area.
- Only two family members at a time during visitation. Minor children must be in the control of an adult that is always present (minor children may not visit independently) and must also comply with social distancing and mask requirements.
- The visit will be monitored from a distance to provide privacy while also ensuring there is no contact that would break social distancing, food/beverages are not shared, and masks/face shields are not removed.
- There is unfortunately no hugging or touching your family member.

- You cannot bring items to be given to the resident immediately. Anything you bring in to give to the resident will need to be quarantined for 72 hours.
- Visitation is Monday thru Friday 10:00 am to 3:15 pm and Saturday 10:00 am to 3:15pm.
- You can schedule as many visits a week as you would like. Only one, thirty-minute visit per day. If you choose to schedule multiple visits per week, secondary and further appointments may be bumped/cancelled ahead of time to accommodate for all to be able to visit.
- Visitor(s) will be instructed that, should they find they were in direct contact with a COVID-19 patient, become symptomatic, or test lab positive for COVID-19 after their visit they must immediately notify the Director of Nursing to ensure that any additional surveillance measures required are put in place as appropriate.
